Particularly, I am personally indebted to Hon. Lady Justice Eusebia Munuo a retired Justice of Appeal but not tired who has always been at our disposal whenever, her services have been required. To us she has always been a source of inspiration as a first female Magistrate in Tanzania and a first Lady Justice of Appeal in Tanzania.

## Dear participants,

This training has been prepared as part and parcel of the implementation of the Judiciary of Tanzania's Five Years Strategic Plan (2015/16-2019/20) particularly Pillar No. 1 Key Result Area (KRA) 2 which focuses on enhancement of Jurisprudence and Skills of Judicial and Non-Judicial Officers as one of its Strategic Objectives. The main focus being to sharpen skills and enhance knowledge of judiciary personnel and therefore improve service delivery as one of its service delivery target (SDT) which will ultimately serve to improve public image of the Judiciary of Tanzania and raise public trust of the ordinary citizens against the Judiciary of Tanzania. The training also seeks to enhance jurisprudence of judicial officers when discharging their judicial functions.

You are all aware that early last year the Minister of Constitutional and Legal Affairs granted an order, extending jurisdiction to 195 Resident Magistrates to perform functions or duties exercisable by judges of the High Court of Tanzania. *The Criminal Procedure (Extension of Jurisdiction) Order*, 2018, which states that:

"Consequent upon investing of extended jurisdiction, the persons referred to in sub-paragraph (1) shall exercise the powers ordinarily exercisable by the Judge of the High Court".

It was incumbent therefore to prepare this tailor-made training as an induction to sharpen further your knowledge and skills as you assume the role of Resident Magistrates with Extended Jurisdiction. The main objective being to enhance your skills and abilities as you will be performing functions or duties exercisable by Judges of the High Court of Tanzania.

## Dear participants,

I wish to assure you that the choice of topics and facilitators were strategically done to ensure that you get the most out of the five days of the training. You will be taken through Criminal as well as Civil Practice and Procedures in as far as Magistrates with Extended Jurisdiction are concerned, Judgment Writing, Sentencing, Fundamental Issues in Land Dispute

Settlement Mechanism and Judicial Mentorship in line with JK Circular No. 2 of 2019. During the training you will also get an opportunity to know how to summarize judgments and upload them in the system for public consumption. The facilitators lined up will be able to share with you first-hand information based upon their vast experience. I hope they will also play the mentorship role beside being mere facilitators. I am aware that Lady Justice Munuo JA (rtd) and Hon. Justice Rutakangwa JA (rtd) served in that capacity before they were appointed Judges of the High Court as such you will be able to greatly benefit from them.

You will notice further that the programme has been designed to allow more interactive engagement than *mere talk and chalk*. I will therefore urge you to be more active, fully participate during Group Activities and engage facilitators and your peers during plenary sessions because it is through engagement that further clarifications and elaborations will be enhanced. I also believe that while doing so you will observe the rule of respecting each other views because when it comes to *Adult Learning* there is nothing like *One Size Fits All*.

In order to ease your leaning process, IJA has prepared a *Compilation of Training Manual* in which you will be able to get hold of various cases which complements *The Guiding Principles and Procedures in The Exercise of the Powers of Extended Jurisdiction*.
