My Lords and My Ladies, Judges of the High Court (Our Most Valued Programme Participants)

Ladies and Gentlemen.

I appreciate so much for your stewardship, support and vision particularly on the planning and arrangements for all the induction training programmes like this one. At IJA, we always rely on you not just for guidance and direction, but also for your inputs on minute details of our professional development programmes for the judiciary staff.

My Lord the Chief Justice, Ladies and Gentlemen.

Most of us are aware that IJA is experienced in conducting and delivering this kind training programmes. Actually, at the beginning of this year we delivered one induction programme for newly appointed judges of the High Court in February and another in March for newly appointed Justices of Appeal. Nonetheless, an induction training like this one cannot happen overnight., the wheels to prepare for this programme only started rolling right after our most valued participants were appointed about two weeks ago. This induction training is certainly an important opportunity for you to acquire and perfect your art, skill and craft of being a judge, which can be summed up as judgecraft. But in order to do so, I would urge you to unshackle yourselves from what may be called the arrogance of knowledge. Until your appointment as a Judge, you may have been a career judicial

officer or state counsel but do not assume that you will have necessarily an easy sailing as a Judge. What the famous American writer, Mark Twain, wrote of himself can carry the message home. He said thus:

"When I was a boy of 14, my father was so ignorant I could hardly stand to have the old man around. But when I got to be 21, I was astonished at how much the old man had learned in seven years."

There is no doubt that arrogance may make you feel powerful, intelligent, knowledgeable and experienced that you are ready to resolve any conceivable legal dispute. But that's foolhardy. I would thus urge that for the entire duration of your training, you should be ready to learn and, where possible, to re-learn.

I believe that you will find the programme rewarding, refreshing and useful.

I wish each of you all the best in your ensuing career as a member of the higher bench in the country.
