ADMISSION REQUIREMENTS:

1.0 TECHNICIAN CERTIFICATE IN LAW (NTA LEVEL 5):

1.1 Entry Qualifications:

- (a) Successful completion of Form Six (VI) or its equivalent with at least ONE (1) Principal Pass, ONE (1) Subsidiary in any relevant subject and having at least **four passes** in non-religious subjects in Form Four examination results.

OR

- (b) Successful completion of Basic Technician Certificate in Law (**NTA Level 4**) from the **Institute of Judicial Administration Lushoto** or any other recognized institution whose results have been verified by NACTVET and having at least **four passes** in non-religious subjects including English Language in Form Four examination results.

1.2 Duration: One Year

**2.0 BASIC TECHNICIAN CERTIFICATE IN LAW
(NTA LEVEL 4):**

2.1 Entry Qualifications:

Successful completion of Form IV or its equivalent with at least **four passes in non religious subjects** including English Language.

3.0 MODE OF APPLICATION:

3.1 All applications shall be made online through the following link <https://online.ija.ac.tz/applications>

3.2 All applicants must pay a non-refundable Application Fee of TShs. Ten Thousand (TShs.10,000/=) through **Control Number** which will be created by applicant during the process of application.

3.3 Applicants who have more than one academic certificate must upload all certificates to prove their eligibility for admission.

3.4 Once applications are received, IJA will process and transmit them to the **National Council for Technical and Vocational Education Training (NACTVET)** for verification.

3.5 Application deadline is on 10th September, 2024.

3.6 Publication of successful applicants will be advertised on IJA's Website www.ija.ac.tz.
